The first-ever P-IE Section organized "Field Tour" will occur on August 22-24, 2017 – 'Balancing Pest Management and Pollinator Health'. The Science Policy Tour is being organized in cooperation with Mississippi State University and was inspired by Dr. Jeff Harris's (Extension Specialist in Apiculture) presentation at the P-IE Afternoon Session during ICE 2016. 
- 2) The P-IE Section will develop a strong reputation of bringing together stakeholders from diverse geographical and philosophical viewpoints, and research areas to share ideas, learn from each other through a specific case study, and to use the venue to capture opportunities and best practices that can be leveraged in new ways. This precedent will help establish P-IE Section members as technical leaders on pollination issues.
- 3) A successful field tour for this Mississippi case study <u>can serve as a precedent for the development of future field tours in other locations, perhaps annually</u>, to address other pollinator case studies or other entomological concerns such as ESA Grand Challenges related to invasive species and sustainable agriculture.
