**Warren Booth, Ph.D.**, associate professor of biological science at the University of Tulsa. Dr. Booth has accepted the Joseph R. & Mary W. Wilson endowed professor of urban entomology in the Department of Entomology at Virginia Tech University. Dr. Booth's research focuses on evolutionary biology, molecular ecology, and population genetics of urban arthropod pests, especially bed bugs and their adaptation to urban environments. He begins his new position in January 2023. Congratulations Warren!



**Phillip Shults, Ph.D.** Dr. Shults recently started in a new position as a research entomologist with the USDA-Agricultural Research Service in the Arthropod-borne Animal Diseases Research Unit (ABADRU) in Manhattan, Kansas. His research has focused on using population genetics to study a variety of MUVE insects, such as *Culicoides* biting midges, dark rover ants, and subterranean termites. In his position with ABADRU, he will continue to focus on the use of population genetic techniques to study vectors and arthropod-borne diseases of animals.

## POLICY CORNER



### **Policy Corner: What is the “Federal Register” and why should you care?**

Entomologists already have to work hard to remain up-to-date on current developments in their field, but there’s another official journal that is worth keeping abreast of: The *Federal Register*. Sure, while you may not find the most recent meta-analysis of off-target effects of organophosphates in the weekly released publication, you will be able to learn what new rules the EPA is proposing governing their study, development, or deployment. You even have the opportunity to submit edits, comments, and concerns. This means that you have another tool you can use to shape federal science policy as it relates to entomology, science funding, or other topics of interest to you. You can directly participate in the federal rulemaking process.

The Federal Register is an official publication of the US Federal Government that comes out daily Monday through Friday, except Federal Holidays. The goal is to inform citizens of their obligations and rights, and it contains major decided or proposed changes in rules, regulations, or policies by any federal agency which will affect the public, as well as Executive Orders and Proclamations, public notices, and more. You can access the *Federal Register* from its [website](#).

There are many ways to navigate the *Federal Register*. You can focus on sections of interest (such as “Environment” or “Science and Technology”), browse for a specific agency (such as the Department of Health and Human Services [HHS], the parent agency of the Centers for Disease Control [CDC]), or directly search for keywords in all of the active documents. If you aren’t interested in coming back daily, you can always sign up for an account and subscribe to the results of any search, document, or agency to get updates sent directly to your email inbox.

So what can you do if you come across a document asking for input on a rule, policy, or request for information that you want to address? Get started early: make note of the deadline and make sure to get it submitted prior to 11:59 PM EST the date the comments are due. If you don’t understand the language or have questions, you can reach out to the agency contact person, ESA, or your MUVE Science Policy Committee [SPC] Representative.

Make sure that the top of your comment includes all of the document information, including docket number, FR date and page number, and subject heading. Include an introduction, relevant background, analysis, and a conclusion with constructive details explaining why you support something or not. And remember, evidence-based information is particularly valuable and convincing, so don’t be afraid to cite relevant statistics, scientific papers, etc. You can find a wealth of more detailed tips for submitting effective public comments to the *Federal Register* from federal agencies, non-profit advocacy groups, and academic institutions with a quick online search.

ESA already does their best to stay up-to-date on topics of relevance to the MUVE section and general Society membership overall. This includes identifying documents, organizing committees to draft comments, and communicating with relevant federal agencies. If you are not interested in signing up for a *Federal Register* subscription, but you are interested in contributing to ESA communication efforts in relation to Science Policy, you can [sign up for ESA Action Alerts](#) or contact your MUVE representative as a volunteer.
