3. Governing Board Representative Report – representative not present

4. ESA Staff Reports

- a. Section Initiatives (Chris Stelzig):
 - i. The ESA Presidential Committee (2015) wanted to empower each of four sections to create section initiatives to benefit section members. Initiatives possible due to changes in 2007 to bylaws. Encourage section to think broader than activities at annual meeting; e.g. MUVE as resource for mosquito-borne diseases.
 - ii. Workshop with Scott Hutchins at Denver summer meeting to determine how sections can build impact for membership. Suggestion for workshop this summer to review tools at national level that the sections can use to meet their objectives.
 - iii. MUVE leadership previously agreed to have a MUVE committee activated after the annual meeting to determine possible objectives for MUVE section activities. Mustapha to work with Chris to develop survey for MUVE member input on section initiatives. Ideas for initiatives include: outreach; increasing public interest in entomology; partner with ESA with activities members are already involved in; come up with ideas to extend to the membership; ESA national help MUVE members gain access to politicians to teach them about changes in pest control required in public housing, or gain access to Department of Education for IPM in schools.
- b. ESA Awards Task Report (Rosina)
 - i. Working for one year to re-evaluate national awards
 - ii. Put out an awards survey; working for the last few months to review results of the survey.
 - iii. Recommendations will include the following:
 - 1. Will no longer require official transcript to save money
 - 2. Moving six awards (including Urban Entomology award to change to MUVE section award) to section awards in which recipient is always from one section.
 - a. Urban Entomology award all nominees are from MUVE. Award is a 6.7 prestige level out of 10.
 - b. MUVE would manage award as section award; money provided by national ESA. Sponsor SC Johnson has already provided the money for the endowment for the Urban Entomology award.
 - c. Must ensure award will not lose prestige moving to the section. All awards now will be handed out at a breakfast at the ESA National meeting.
 - d. Suggestion for SC Johnson to include medical in the award based on recommendation from Jennifer Gordon as former employee. MUVE leaders considered broadening

the award if that is possible given the donor expectations to allow more MUVE members to apply.

- e. Section will adopt the award as is; solicit nominations, review nominees, and form a task force to look at criteria for award.

5. MUVE Officer Reports

- a. Jennifer Gordon - Science Policy Committee:
 - i. ESA published its first infographic on gene drive (e.g. Oxitec) on website. Limit mosquito's ability to transfer disease.
 - ii. Finishing position statement on endangered species act.
 - iii. Lewis-Burke law firm reviewed 2018 appropriations bill - more money granted to NIH, CDC, EPA, etc.
 - iv. Jennifer briefed about 30 congressmen – discussed mosquito and tick borne diseases. Important to get funding for mosquito control. Presentations given to different committees on Zika virus focusing on management of vector mosquitos.
- b. Ken Brown – Membership drive: new networks more active and details are on the ESA web site.
- c. Ronda Hamm – Education and Outreach Committee:
 - i. Committee has been granted a workshop at the annual meeting – Hands-on activities on natural selection, phenotypes, DNA extraction, and earth without insects designed to develop communications for public speaking and use in classrooms.
 - ii. Submitted Symposium for Education and Outreach was not approved for 2017 ESA national meeting, but education/ outreach talks are being arranged together as submitted 10 min talks.
