Wildly Important Goal #1:

MUVE Vector Emergency Response Entomologists

Mustapha Debboun, the initiative leader of MUVE Vector Emergency Response Entomologists continues to add to the pool and database of disaster and emergency response volunteer entomologists who are willing to deploy to natural disaster-affected areas nationally and internationally for emergency mosquito and vector control response and help streamline emergency response when emergency medical entomology expertise is needed nationally or globally.

Wildly Important Goal #2:

Improve Integrated Pest Management Strategies in Public Housing Facilities.

The objective of this sub-committee is multi-pronged in approach. We intend to continue to educate staff and landlords associated with public housing facilities, as well as ensure that upto-date and accurate literature is available to them in an accessible format. We will assemble urban entomologists to conduct research to identify issues in public housing related to pest infestations and methods to improve pest management in these communities. The sub-committee will cooperate with HUD, EPA, and other federal agencies and stakeholders to implement safer and more effective pest management policies. We will identify and share funding opportunities to assist in the implementation of IPM in these facilities. Urban entomologists associated with science policy will lobby for continued funding at a federal level. Current endeavors include assessing HUD contracts and making recommendations for improvement, as well as developing a nation-wide IPM handbook for extension entomologists and other stakeholders working with urban pests.

Wildly Important Goal #3:

Identify Existing Training Opportunities for Veterinary Entomologists.

Based upon MUVE member responses to the request for information on training courses (available and need) that was sent out in our previous newsletter and by ESA Central on our behalf, we compiled an excel spreadsheet listing training courses that are relevant to MUVE members and are currently available. The second tab of the spreadsheet includes member responses on "what training is needed". This list may be used to provide direction on what training opportunities MUVE members might consider developing in the future. We added a few more online keys to the list of online material that is available.

Other Goals:

The MUVE Communications Committee was established to help enhance outreach and communication pertaining to MUVE news and MUVE-related content. The liason for this committee, Dr. Bethany McGregor (USDA-ARS) is organizing a networking event after our final business meeting on November 20th (2-3 PM via zoom; a google form poll was sent out for people to RSVP). This event is a kick off to generate interest and participation in MUVE mentoring, which will likely be a forthcoming WIG/Initiative in 2021.
